If any long pending cases due to non-receipt of reports from the examiners or non-availability of the examiners an alternative arrangements will be made for the welfare of the research scholars.

This resolution was passed.

4. Resolved that the University to be requested to publish the results of III UG/ II PG courses only in TVU website and students can get it digital marks statement individually with their own username and password to pursue their higher education instead of producing galley results at the time of admission.

Resolved that the above resolution will be considered in future when the digitalization of examination work introduced at our University.

**5.** Resolved that the University to be requested to permit the NON-CBCS students (before 2008-2009) to reappear the examinations as a final chance.

Resolved that the above resolution will be placed before the Syndicate for consideration.
